

PARTNERSHIP AGREEMENT
Between
The Children's Care & Nabeel And Huzaif LLC

Effective Date: December 29, 2023

This Partnership Agreement ("Agreement") is made and entered into on **December 29, 2023**, by and between **The Children's Care**, a non-profit organization, and **Nabeel And Huzaif LLC**, a registered entity in the United States, collectively referred to as "Parties." This Agreement establishes the terms and conditions under which **Nabeel And Huzaif LLC** will support **The Children's Care** in raising Zakat and related charitable funds in the United States.

1. Purpose of the Agreement

The primary purpose of this Agreement is to outline the responsibilities and commitments of both Parties in collecting and managing Zakat, Sadaqat, and Fitrah donations for the benefit of **The Children's Care**.

1. **Fundraising Authorization:** Nabeel And Huzaif LLC is authorized to collect Zakat, Sadaqat, and Fitrah donations in the United States exclusively for The Children's Care.
2. **Fundraising Platforms:** Nabeel And Huzaif LLC is authorized to publish and promote fundraising campaigns on any **crowdfunding platform, Islamic center, individual, or charitable organization** in the United States to collect funds for The Children's Care.
3. **Technical Assistance:** Nabeel And Huzaif LLC agrees to provide technical support, including but not limited to **website development and online donation systems**, to facilitate The Children's Care's fundraising efforts.
4. **Volunteer-Based Work:** Nabeel And Huzaif LLC will perform all activities **voluntarily for humanitarian purposes** without receiving any payment or commission from The Children's Care.

2. Transparency & Compliance

1. **Financial Accountability:** Both Parties agree to maintain complete transparency in **financial transactions** and ensure that funds raised for The Children's Care are properly documented and publicly accounted for.
2. **Government Compliance:** Both entities shall comply with all applicable **financial and taxation regulations** in their respective countries and ensure proper filing with relevant authorities.
3. **Use of Funds:** All funds collected shall be used **exclusively for the Muslim community's welfare** and **shall remain public funds, not for any personal interest**.

3. Conflict Resolution & Termination

1. **Board Review:** In case of any dispute between the entities, the matter shall be resolved through a **board meeting** with representatives from both Parties.
2. **Agreement Cancellation:** Either Party may terminate this Agreement if necessary, with mutual consent and proper financial reconciliation.
3. **Fund Protection:** In case of Agreement termination, any **remaining funds shall continue to be used solely for charitable purposes** and transferred appropriately.



4. General Provisions

1. **Non-Exclusive Agreement:** This Agreement does not restrict either Party from engaging in other lawful activities for community welfare.
2. **No Employment Relationship:** This Agreement does not create an employer-employee relationship, joint venture, or agency between the Parties.
3. **Legal Binding:** This Agreement is legally binding upon both entities, and any amendments must be made in writing and signed by both Parties.
